COMPANY BACKGROUND

It is a joint venture company and the parent companies are CITIC Securities International Company Limited which is a wholly-owned subsidiary of CITIC Securities Co., Ltd, a leading investment bank based in China and listed on the Shanghai Stock Exchange, and China Alpha Fund Management Limited which is the lead manager of China focused offshore hedge funds.

CSIIM acts as the investment manager and advisor of various hedge funds, a listed fund and an authorized fund approved by the SFC.

The Compliance department of CSIIM is responsible for ensuring that there are adequate internal control procedures in compliance with the relevant rules and regulations, that the compliance manual is strictly followed by all staff and that all relevant laws, rules and regulations are updated and abided by.
